# Childcare Allowance

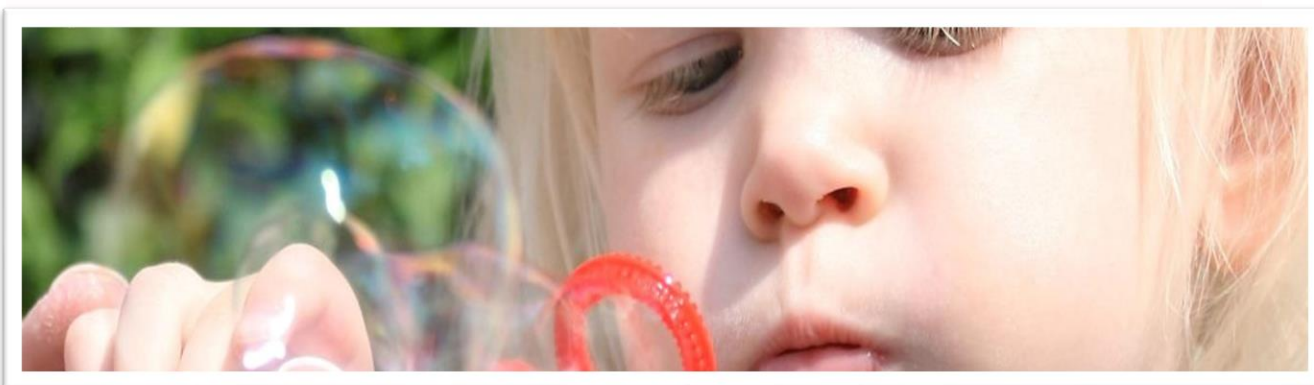

## Information

In order to receive childcare allowance, you and your allowance partner, if any, must meet conditions. This depends on the amount of your income, the number of children and the type of care. You can receive childcare allowance per child for a maximum of 230 hours per month. There is also a maximum hourly rate. You can apply for your childcare allowance for 2025 with my allowances. You must apply for the allowance within 3 months of the month in which your child first goes to daycare. Do not wait too long to apply, otherwise you will miss out on a surcharge! If you want to be eligible for childcare allowance, you must meet a number of conditions together with your allowance partner. For more information, I refer you to the website of the Tax Authorities/allowances.

## Passing on changes to the tax authorities

Do you receive childcare allowance and does something change in your situation? For example, if your income changes or the number of childcare hours, this will have consequences for your allowance. You must notify us of any changes in your situation within 4 weeks. Then pass it on via the Tax Authorities / allowances.

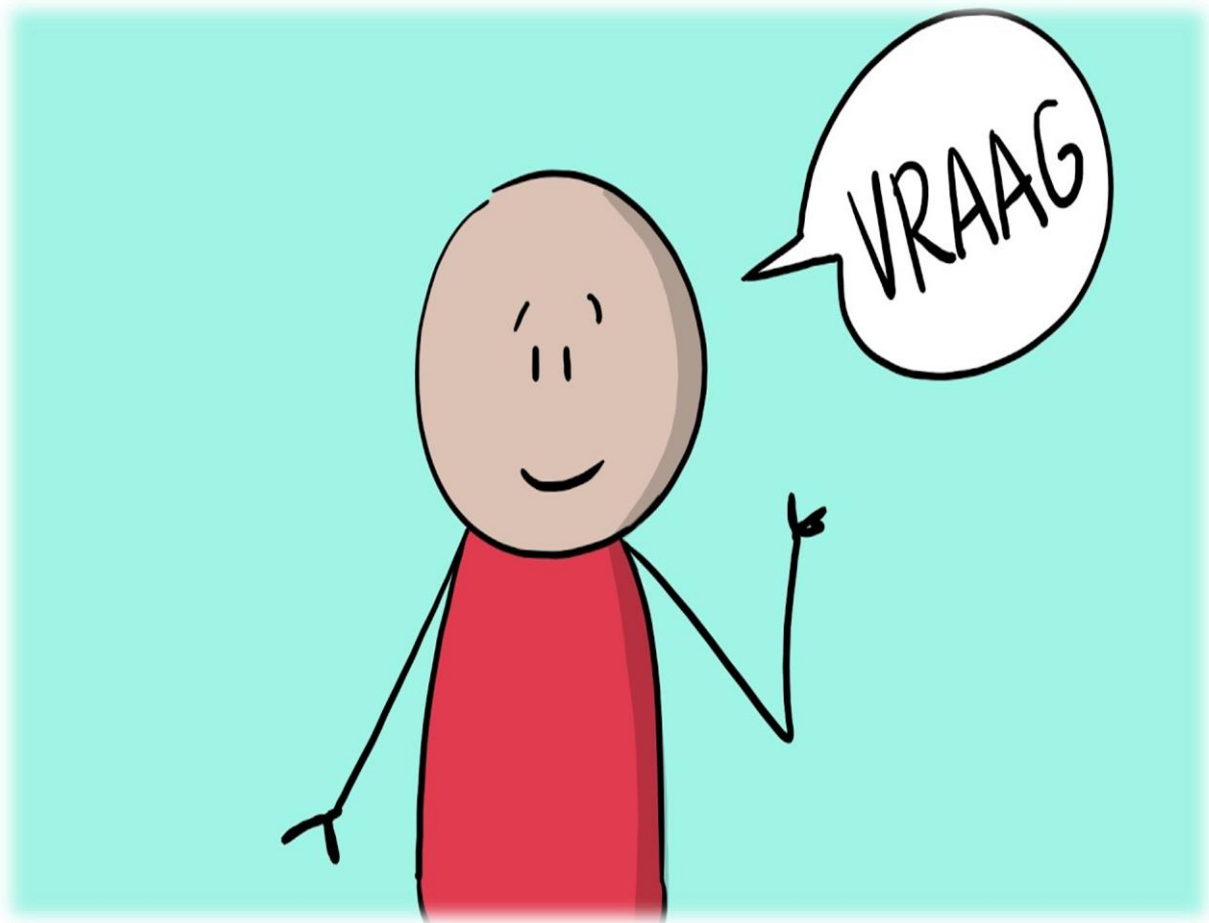
